2. **Date and Time of Document Verification: 02-03-2022 (Wednesday) from 9am onwards**
3. **Date and Time of Interview: 02-03-2022 (Wednesday) from 10.30 am to 4pm and if the registered candidates are more than 40, Interview will be extended to next day(03.03.2022).**
4. **Appointment shall be for the duration of one year. The contract will be valid either up to the date when regular incumbent joins or one year from the date of appointment, whichever is earlier.**
5. The crucial date for determining the Age limit, work experience and other criteria regarding eligibility for the post shall be the date of interview that is **02-03-2022 (Wednesday)**.
