TERMS AND CONDITIONS FOR ENGAGEMENT OF EXECUTIVE (MARKETING), EXECUTIVE (DEVELOPMENT) & TRADE ANALYST IN SPICES BOARD

- 1. The remuneration payable would be Rs. 30,000/- per month for first year and Rs 35,000/- per month for the extended period in applicable cases. The remuneration for service rendered in a month shall be payable in the subsequent month.
- 2. The period of engagement will be initially for one year and is further extendable by one more year as per requirement and based on performance.
- 3. Executive (Marketing), Executive (Development) & Trade Analyst shall not be entitled to any kind of allowance or accommodation facility eg. Dearness Allowance, Transport Facility, Residential Accommodation, Personal Staff, CGHS and Medical Reimbursement etc
