GENERAL MANAGER, HIGH EXPLOSIVES FACTORY, KHADKI, PUNE, invites applications for engagement as apprentices in accordance with the provisions contained in the Apprentices Act, 1961 (amended in 1973, 2014 & 2019) for providing practical training to fresh Engineering Graduates & Diploma (Technician) in Chemical Engineering, Mechanical Engineering, Electrical Engineering & General Stream Graduates for a period of one year during 2024-25 as per details given below :-

2) **ESSENTIAL EDUCATIONAL QUALIFICATION :-**

Graduate Apprentice : Degree in Engineering/Technology or Degree in General Streams from a recognized University (* as mentioned below)

Technician Apprentice : Diploma in Engineering/Technology from Board of Technical Education of a state.

* General Stream Graduates : Degree in Bachelor of Arts, Bachelor of Science, Bachelor of Commerce, Bachelor of Computer Applications, Bachelor of Business Administration, Bachelor of Hotel Management, Bachelor of Fashion Designing, Bachelor of Management Science, Bachelor of Fine Arts, Bachelor of Event management, Bachelor of Journalism and Mass Communication, Bachelor of Social Work, Bachelor of Business Studies, Bachelor of Travel and Tourism Management, Bachelor of Design and Bachelor of Performing Arts.

Only Fresh Pass Out students of above notified trades/disciplines are eligible for Apprenticeship Training only up to 4 years after passing their degree/diploma as on last date for receipt of application. Engineering Graduate holders who had training or job experience for a period of one year or more after attaining the essential qualifications shall **NOT** be eligible for being engaged as an apprentice under the Act.

If the gap between the date of declaration of result and date of commencement of training is more than one year, an affidavit on stamp paper duly signed by Magistrate/Notary has to be submitted by the candidates. Matter of the affidavit will remain same as of declaration in the format enclosed as **Annexure – 'B'**

3) **SELECTION PROCEDURE**

Selection will be based on the merit list prepared on marks obtained in the Final Year Examination i.e., CGPA percentage for Engineering Graduates/Technician.

Candidates meeting the eligibility criteria should forward their completely filled applications by post in the prescribed format with declaration that they will submit all desired documents at the time of Document Verification. In case of failure to submit any of the desired documents, his/her candidature will be rejected.

Deferment of date of Document Verification (when notified) will not be permitted/considered.

Candidates found clear in Document Verification will be called for Medical Examination before joining after receipt of satisfactory online Police Clearance Certificates (PVRs)/Verification of Character antecedents. Candidates found FIT in Medical Examination will be issued joining letter for Apprenticeship Training.

4) **GENERAL INFORMATION**

Application (as per Annexure-A) to be forwarded in sealed envelope with title as "APPLICATION FOR ENGAGEMENT AS GRADUATE/DIPLOMA APPRENTICE". Incomplete applications/applications received after the last date will not be entertained.

6) **RESERVATION**

As per the provisions contained in the Apprentice Rule 2015. Copy of certificate from competent issuing authority is required to be submitted for obtaining Reservation. OBC candidates are required to submit Non-Creamy-Layer-Certificate (NCLC) valid as on closing date of receipt of application. Candidates not having valid certificate in respect of Reservation will be considered as unreserved candidate.
