**VACANCY NOTICE**

**Subject:** Filling up the post of Accountant on deputation/ promotion basis

The National Institute of Naturopathy, Pune, an autonomous body, under the Ministry of Ayush, Government of India, proposes to fill one post of **Accountant on deputation/ promotion** basis. The required qualifications and eligibility criteria for the post are given below: -

**Name of the Post:** Accountant

**Level in the Pay Matrix:** Level 6 (Rs. 35,400 – 1,12,400), in the Pay matrix, as per the 7<sup>th</sup> CPC.

**Number of Post(s):** One

**Eligibility Criteria:** Officials under the Central Government/ State Government or Autonomous Bodies:

- i. Holding analogous posts on regular basis **OR** With 6 years' regular service in posts in Level 5 in the Pay Matrix (Rs. 29,200 – 92300) **OR** With 10 years' regular service in posts in Level 4 in the Pay Matrix (Rs. 25,500 – 81,100)

**AND**

- ii. Who have undergone training in Cash and Accounts in the ISTM or equivalent and possess 3 years' experience of cash, accounts and budget work **OR** a pass in the SAS or equivalent examination conducted by any of the organized Accounts Department of the Central Government.

**Note 1:** The Departmental candidates possessing qualifications and experience prescribed for direct recruitment will be considered along with other candidates and in the event of their selection their appointment will be treated as promotion.

**Note 2:** The following qualifications and experience have been prescribed for Direct Recruitment:

- i. B. Com. from a recognized university
- ii. At least 5 years' experience in Government/ Semi-Government/ Autonomous Bodies/ Public Sector Undertakings of repute dealing with budget, maintenance of accounts, preparation of bills etc.

**OR**

- i. Graduate from a recognized university
- ii. Passed SAS Examination of CAG of India/ JAO (C) Exam.

iii. About 5 years' experience in an audit office/ Department of Central/ State Government.

**Note 3:** The period of deputation shall ordinarily not exceed three years.

**The maximum age limit:** Not exceeding 56 years as on the closing date of receipt of applications.

**General Conditions:**

1. Application in the proforma given in **Annexure** to this circular may be sent by speed post to Director, National Institute of Naturopathy, Nisarg Gram, Opp. Vidyashilp Public School, Yewalewadi, Pune – 411048.
2. The envelope containing the application duly filled in and supported by all relevant documents should be superscribed "**Application for the post of Accountant**".
3. While forwarding applications photocopies of the ACRs/ APARs for the last five years, with each page duly attested by an officer not below the rank of Under Secretary to the Government of India, Cadre Clearance, Vigilance Clearance, Integrity Certificate and Statement showing Major and Minor penalties, if any, imposed during the last ten years, are required to be furnished by the sponsoring authority.
4. The Officers selected under deputation will have the option to draw his/her pay plus deputation (duty) allowance or to have his/ her pay fixed in the scale/ level of the post in accordance with DoPT's O.M. No.2/12/87-Estt (Pay II) dated 29.04.1988, as amended from time to time.
5. **The last date for the receipt of application in the Institute is 31.03.2026.** If a candidate anticipates delay in the forwarding of application through proper channel, he/ she may send an advance copy of his/ her application at the above address, ensuring that the advance copy reaches this Institute by the last date.
